NOTIFICATION

Applications are invited for filling up of the post of Chief Executive Officer (CEO) for the District Cooperative Central Banks viz., **Guntur, Anantapur and Chittoor** from suitable candidates who fulfill the following Fit and Proper Criteria prescribed by RBI/NABARD.

I. AGE:

The applicant shall be not above 62 years of age as on the date of notification.

II. QUALIFICATIONS:

The person to be appointed as CEO shall at least be a:

- a) Graduate with CAIB / DBF / Diploma in Cooperative Business Management or equivalent qualification;*
- b) Chartered or Cost Accountant or*
- c) Post Graduate in any discipline;*

III. EXPERIENCE:

The applicant shall have at least 8 years' work experience at the middle/senior level in the Banking Sector. Senior/Middle level for the purpose shall be taken as the third level (Scale/cadre) onwards [i.e., excluding the first two levels (scales/cadres) in the Officer cadre], or as the highest two levels (scales/cadres) below the level of CEO.

IV. SCALE OF PAY:

- a) Rs.59170 - 1650/2 – 62470 – 1800/2 – 66070 (5 stages) and no Stagnation Increments. Further, the CEOs selected under Fit & Proper criteria from any / same DCCB or APCOB, 15% on the Basic Pay drawn, will be given as Special Allowance which does not carry any further allowance on this Special Allowance.*
- b) Perks and allowances will be extended as decided by the respective Boards of Management of the DCCBs.*

V. GENERAL CONDITIONS:

- 1. The appointment will be for an initial period for 3 years on deputation/contract basis.*
- 2. In-service candidates should apply through proper channel.*
- 3. Interested candidates may submit their applications in the prescribed format with all supporting documents of their credentials along with the application fee of Rs.500/- by way of Demand Draft drawn in favor of "THE ANDHRA PRADESH STATE COOPERATIVE BANK LTD" payable at Vijayawada.*
