NOTIFICATION

Applications are invited for filling up of the post of Chief Executive Officer (CEO) for the District Cooperative Central Banks viz., Krishna & Eluru* from suitable candidates who fulfill the following Fit and Proper Criteria prescribed by RBI/NABARD:

**The post of CEO, Eluru DCCB falls vacant on 21.06.2021.*

I. AGE:

The applicant shall be not above 62 years of age as on the date of notification.

II. QUALIFICATIONS:

The person to be appointed as CEO shall at least be a:

- a) Graduate with CAIIB / DBF / Diploma in Cooperative Business Management or equivalent qualification; or*
- b) Chartered or Cost Accountant or*
- c) Post Graduate in any discipline;*

III. EXPERIENCE:

The applicant shall have at least 8 years' work experience at the middle/senior level in the Banking Sector. Senior/Middle level for the purpose shall be taken as the third level (Scale/cadre) onwards [i.e., excluding the first two levels (scales/cadres) in the Officer cadre], or as the highest two levels (scales/cadres) below the level of CEO.

IV. SCALE OF PAY:

- a) Rs.59170 - 1650/2 – 62470 – 1800/2 – 66070 (5 stages) and no Stagnation Increments. Further, the CEOs selected under Fit & Proper criteria from any / same DCCB or APCOB, 15% on the Basic Pay + DA drawn, will be given as Special Allowance, which not carry any further allowances.*
- b) Perks and allowances will be extended as decided by the Board of Management of the DCCB.*

V. GENERAL CONDITIONS:

- 1. The appointment will be for be an initial period for 3 years on deputation/contract basis.*
- 2. The application should be submitted in the prescribed format only.*
- 3. In-service candidates should apply through proper channel. In case, the candidate anticipates any delay in forwarding his/her application for want of employer recommendation, he/she may submit advanced copy of application along with all the requirements (except employer recommendation) before the last date i.e15.04.2021. However, the application, duly recommended by the employer, shall reach the Bank by 26.04.2021.*
- 4. Applications not complying with the conditions of age, qualifications, experience, fee, proceedings if any, employer recommendations etc., will be summarily rejected.*
- 5. A recent passport size photo is to be pasted on the application in the space provided.*
- 6. Application should be accompanied by attested true copies of certificates pertaining to proof of date of birth, qualifications, experience and other credentials with the prescribed fee of Rs.500/- by way of Demand Draft favoring " THE ANDHRA PRADESH STATE COOPERATIVE BANK LTD" payable at Vijayawada.*
